

APRIL 5, 2011 CONSOLIDATED ELECTION

Tuesday, September 21, 2010

First day to circulate petitions for new party, independent and nonpartisan candidates

Monday, December 13-20, 2010

Filing period

Tuesday, December 28, 2010

Last day to file objections to nominating petitions

Wednesday, December 29, 2010

Last day for election official to conduct lottery to determine the order in which candidates will appear on ballot

Monday, January 3, 2011

Last day to file petition for referenda (Referenda that can be initiated by petition)

Monday, January 10, 2011

Last day to file objections to petitions for referenda

Tuesday, January 18, 2011

Last day for governing body to adopt resolution to place referenda on ballot

Thursday, January 27, 2011

Last day set by statute for candidate to file Withdrawal of Candidacy in the office of the local election official or election authority

Thursday, January 27, 2011

Last day for local election official to certify candidates

Thursday, February 3, 2011

Last day for the circuit court clerk and the local election official to certify any question for the April ballot

Thursday, February 3, 2011

Last day to file a declaration of intent to be a write in candidate

Tuesday, February 22, 2011

Last day for the election authority to have ballots ready for mailing to persons in the United States Service or their spouse or dependents and citizens of the United States who are temporarily residing outside the territorial limits of the United States and nonresident civilians

Thursday, February 24, 2011

First day for any registered voter presently within the confines of the United States, to make application to the election authority for a ballot

Tuesday, March 8, 2011

First day for the election authority to publish notice of the Consolidated Election

Tuesday, March 8, 2011

Last day for registration or transfer of registration

Wednesday, March 9, 2011

First day of grace period registration and voting

Wednesday, March 9, 2011

Posting of schedule for early voting at each location where early voting is to be conducted

Monday, March 14, 2011

First day for early voting

Friday, March 18, 2011

Last day for election authority to submit voter registration information to the State Board of Elections

Monday, March 28, 2011

Last day for the election authority to publish notice of the Consolidated Election

Tuesday, March 29, 2011

Last day for grace period registration and voting

Thursday, March 31, 2011

Last day for early voting

Thursday, March 31, 2011

Last day to conduct public test of automatic tabulating equipment

Thursday, March 31, 2011

Last day for election authority to receive applications, by mail, from any registered voter who expects to absent from the county on Election Day

Thursday, March 31, 2011

Last day for election authority to publish the specimen ballots labels

Friday, April 1, 2011

Saturday, April 2, 2011

Sunday, April 3, 2011

Monday, April 4, 2011

Dates that Nursing Home Voting will be conducted

Monday, April 4, 2011

Last day for any registered voter, presently within the confines of the United States, to vote an "in person" absentee ballot

Thursday, April 7, 2011

Voter registration opens

Thursday, April 7, 2011

Last day a provisional voter may submit additional information to the County Clerk to verify or support his/her registration status

Tuesday, April 19, 2011

Deadline for election authority to complete the validation and counting of provisional ballots

Tuesday, April 19, 2011

Deadline for the election authority to complete the tabulation of absentee ballots that were (1) postmarked by midnight preceding the opening of the polls on Election Day, and were received after the close of the polls on Election Day, but not later than 14 days after the election, or (2) not postmarked at all, but did have a certification date prior to the Election Day on the certification envelope, and were received after the close of the polls on Election Day but not later than 14 days after the election.

Tuesday, April 26, 2011

Last day for canvassing election results by County Clerk

Friday, May 6, 2011

Last day for the SBE to canvass results for the Fox Waterway Management Agency offices

Thursday, May 26, 2011

Last day for election authorities to submit voter registration information to the SBE
