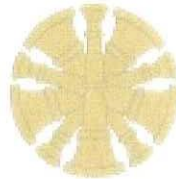

Contact your local Fire Protection District.

Some Fire Districts have fire prevention codes and ordinances regarding building requirements that effect your decision to build. The Fire Districts can enforce their codes and ordinances independently of the county. Information on which Fire District you are in is on the last property tax statement for the intended building site. You will need to contact the following Fire District if you plan on building in their jurisdiction.
